The first Health and Wellbeing Strategy for Wirral is now available. It sets out the overarching framework that describes how the public, private and voluntary sectors will work together with Wirral residents to improve the health and wellbeing of local people. The Health and Wellbeing Board strategy provides a basis for the commissioning of health, social care and wellbeing services in Wirral.

Health needs assessment of offenders in the community Cheshire East, Cheshire West & Chester, Warrington and Wirral

This is now available for Wirral and the surrounding area as its first Health Needs Assessment (HNA) for offenders in the community. The research, on behalf of NHS Cheshire, Warrington & Wirral, seeks to understand the health needs of offenders in the community in order to inform local Clinical Commissioning Groups (CCGs), Local Authority (LA) and Local Area Teams of the NHS Commissioning Board (NHS CB LAT) to their current and future commissioning arrangements.

Recent news stories

<u>National Child Measurement Programme and analysis of obesity levels in England</u>

A Public Health England trend analysis report has shown that children from deprived areas are almost twice as likely to be obese than those in affluent areas.

The report *Changes in children's body mass index between 2006/07 and 2011/12*, was presented by Caroline Hancock, Senior Public Health Analyst at Public Health England, at the European Congress on Obesity.

The study used information from the National Child Measurement Programme (NCMP), an annual programme which measures the height and weight of over 1 million children in England in Reception (4 to 5 years) and Year 6 (10 to 11 years).

- Perhaps the most important issue the study showed is that obesity among children who live in the most deprived areas of England is around twice that of children living in the least deprived areas.
- Obesity levels among Reception year children living in the 10% most deprived areas in 2011 to 2012 was 12.4% compared to 6.2% of Reception year children living in the 10% least deprived areas.
- Obesity levels among Year 6 children living in the 10% most deprived areas in 2011 to 2012 was 24.2% compared to 12.8% of Year 6 children living in the 10% least deprived areas.
- In both school years there is evidence that social inequalities in obesity levels have been widening over the 6 years covered by the NCMP

This study by Imperial College examines the association between access to primary care and emergency department visits in England. <u>Findings</u> show that the number of visits to hospital emergency departments in England has increased by 20% since 2007/08, placing greater pressure on the NHS.

Dying well at home: the case for integrated working Social Care Institute for Excellence (SCIE) Guide 48 (May 2013)

The aspects it covers are 'extra care', sheltered housing accommodation and tenancy-based accommodation such as supported living, but not care homes.
